

# The Opportunity

#### We have a unique opportunity to create a community hub building that will provide new facilities for services to meet the needs of residents of Teddington and the surrounding villages both now and in the future.

People are at the heart of our communities. We are committed to being a borough where everyone can live as independently as possible with good health and wellbeing, and when residents need support they can access it close to where they live.

The organisations below provide services in Teddington commissioned by the Council and are therefore directly involved in shaping these plans. We welcome their views and those of the wider community in planning a new community hub for

charity based at Elleray Hall which runs a social centre, providing group activities, the opportunity to socialise and a cooked lunch, in a friendly and welcoming environment.



#### working together for independent living

Ruils (Richmond Users Independent Living Scheme) is a charity that supports children and adults with disabilities and the elderly to live independently, be part of their community and to live life to the full. They provide information, advice, advocacy, befriending and activities to their clients and their families.



Richmond AID is a charity run by and for disabled people in the London Borough of Richmond upon Thames and surrounding areas. They support people of all ages with all disabilities, including physical and sensory impairments, mental health issues and learning difficulties. Their aim is to support disabled people to live independent lives and to have the same opportunities as non-disabled people. They provide information, advice, activities and services for their service users.

There are three sites owned by the Council in Teddington which form part of this proposal.

In 2017, the Council engaged a firm of planning and urban design consultants, Tibbalds, to work alongside the community and Council on a feasibility study and viability assessment of these three sites.

# The Idea

# To create a high quality, sustainable, purpose-built community hub at the heart of Teddington, bringing together existing services and meeting the needs of residents.

This building would be designed to accommodate community based activity suitable for meeting different needs, both now and in the future. The existing service providers will be offered the option of relocating to the new building.

The aim is to provide a building in Teddington that has been shaped by local users and for community activity to thrive. We want the people who use and will use the services to have their say. The response to this event will help inform our consultation and drop-in events, which will be held in the summer of 2018.

Any proposals for the sites need to be approved by the Council's Cabinet and it is likely that a decision will be made on whether the project is viable by the end of 2018.



# Things to Consider

There are many considerations that we know we will need to take into account in progressing this project. Some of these are listed below.

#### Access and Parking



Access and parking will be critical and we want to hear your views so that these can be taken into account.

Other topics to be considered include traffic, travel planning, siting and design, impact on residential amenities (such as privacy, light, noise, and visual impact – trees).

A high level transport study has been compiled as part of the feasibility study and recommendations made will be taken into consideration.

#### Transport



#### Value for Money




We are committed to delivering high quality and value for money community spaces for community activity to take place, however it is important to recognise that this is against an increasingly challenging financial environment. In order to deliver a new community hub the project will need to be financially viable.

#### Planning



Any proposal to be developed would need to take into account the relevant planning policy and restrictions for the sites. E.g. loss/re-provision of community use or office space, housing requirements, design, amenity and massing of buildings, listed buildings, conservation areas and other planning restrictions.

Continuity of Service



We are committed to engaging with current service users of the sites to take into account their current and future needs. Any proposals would look to reduce the impact of this project on the service users and will consider intermediate arrangements if needed and options for transition to a new site.

#### **Future use**



It is a requirement that any proposal meets current need but also takes into account future need. For example, there is a projected population growth in the borough of 8% by 2025 and by 2030 it is projected that the percentage of over 65s will have grown by 40%. We also know that people want services close to where they live. We want to understand better what people need now and in the future to inform this proposal.





# What could this look like?

Richmond Council wants to hear from people who use the services and local residents about what we have found out so far, and what we need to consider as part of this proposal.

This project is in the early stages and no plans have been made in respect of any of the sites. There are considerations to take into account on all sites and further exploration will be needed to check that any plans are feasible and viable.

As part of the feasibility study we have met with the trustees of Elleray Hall, Richmond AID and Ruils. Discussions have included the following suggestions for the community hub:
