**Controlled Parking Zone (CPZ), Zone T4
 Manor Road area Consultation – Questionnaire for Completion**

The Council has received a petition from residents of Manor Road (between Cambridge Road and Twickenham Road requesting the existing controlled parking zone (Zone T4) be extended to this road. It is understood that these residents have signed this petition in view of difficulties they are experiencing in parking near to their home.

We are now consulting the Manor Road area on whether this and adjacent roads should join Zone T4 – see attached map. We have included some adjacent roads due to their close proximity to Manor Road and the possible displacement existing and new parking controls can bring to these roads. St Albans Gardens has been included in the consultation but no parking controls would be applied to that road as it is private.

Zone T4 operates 10am to noon, Monday to Friday - see attached map.

If all or part of this area is added to Zone T4 residents and their visitors parking on street during the operational period of the zone will be required to purchase and display a valid parking permit. You will not be able to purchase a permit if you live in a property subject to a s106 Planning Agreement which restricts or prohibits the issue of permits.

Details of Zone T4 parking permit prices are as follows:

Permit Type	Cost
Resident	£63.80 per year
Resident Visitor	£1.65 per day
Business	£213.40 per year

Resident and Business permits

The above resident and business permit prices are for the first permit issued per household/business for one year. Subsequent resident permits purchased per year are approximately 100% more for the second permit and 200% more for the third and further permits issued. Subsequent business permits purchased are approximately 50% more for the second permit purchased per year and 50% again for third and further permits issued.

Resident visitor permits

Resident visitor permits (scratch cards) are available at half the standard price to the over 60s. These permits must be validated for the relevant time period.

Please note that parking charges are reviewed annually.

The Council would like to demonstrate that any extension to a CPZ has the support of residents so a good response is very important, although the Council will not base its decision on residents' wishes alone. All feedback to this consultation will be considered by the Council along with all relevant traffic management and other highway factors, prior to a decision being made on the way forward.
